· Safety and Health Management Policy

CJ CheilJedang has set the safety of the local community and employees as the first principle of management under the safety and health management policy of 'Creating an ONLY ONE safety-first culture that puts the safety of the local community and employees as the top priority in management.' In order to practice the safety management philosophy, we have established and implemented a safety management system.

· Establishment of Safety and Health Management System

In January 2022, CJ CheilJedang established the 'Safety Management Office', which serves as the company-wide safety management control tower, to reinforce professional manpower and reorganize related regulations and guidelines. In addition, under the supervision of the Safety Management Office, safety and health plans are established and reported to the Board of Directors every year. The safety and health management system is further upgraded through the acquisition of certifications in the safety and health management field such as KOSHA-MS and ISO45001 and verification by external accredited organizations, and the participation of workers and others in safety and health-related consultative bodies is guaranteed.
